CONFIDENTIALITY AND PRIVACY

This Privacy Policy, effective June 1, 2020, is to keep you informed about the types of information collected on the website and how the information is used and protected.

GCRBL, does not collect Personally Identifiable Information (“PII”) about individuals who visit our site except when the information is specifically provided on a voluntary basis. Only aggregated data from these analyses will be provided to third parties. GCRBL may sometimes permit third parties to offer subscription and/or registration-based services through our site.
